### Information collected:

- Name
- Address
- Date of Birth
- Telephone numbers

- Attendance
- Assessments (including daily evaluations, i.e. progress, behaviour and achievement)
- Emergency contacts
- Photo and social media permission

All information is gathered on a Learning Grove referral form, these are completed by parents or guardians and must be signed to give consent to sharing information if necessary.
